Regulations for Penalties and fines (2016)

1. Penalties for Players

S. No.	CASE	PENALTIES
1	Kicking the ball intentionally after the Match (Written Report)	Warning+ \$ 1000 Fine
2	Unsporting conduct towards the Officials / Players / Spectators / Referees / AHF Representatives	1 - 4 Matches suspension + \$ 3000 Fine
3	Removing the Shirt as a protest	1 Match suspension + \$ 1000 Fine
4	Tearing the Players Registration Form or any other official papers related to the Match	1 – 6 Matches suspension + \$ 3000 Fine
5	Throwing the Medals or Trophies after receiving or refusing to go to the podium	1 - 3 Matches suspension + \$ 3000 Fine
6	Incitement which results in withdrawing a team from the Playing Hall	1 – 6 Matches suspension + \$4000 Fine
7	Trying for a Physical Assault	1 - 4 Matches suspension + \$ 4000 Fine
8	Physical Assault (spitting on the persons, Referees, Referees on the bench, Players, Officials, Representatives of AHF, will be considered as physical assault, so will be penalized according to the Article no. 8.10.a – which is suspension with report)	1 - 8 Matches suspension + \$ 8000 Fine + Raising the matter to the Executive Committee
9	Causing A Riot by Raising the spectators	1 - 6 Matches suspension + \$ 5000 Fine
10	Taking part in a Riot	1 - 8 Matches suspension + \$ 8000 Fine + Raising the matter to the Executive Committee
11	Making Remarks through Media which creates disrepute to the Game	1 - 2 Matches suspension + \$ 5000 Fine
12	Using a suspended player	His team will lose the match 10:0 + \$ 2000 Fine + Suspension until the end of the Championship + raising the matter to the Executive Committee for necessary action
13	Use of players who are not entitled to play	His team will be disqualified from the current championship + \$ 10000 Fine + raising the matter to the Executive Committee for necessary action

-The Technical Committee has the right to take necessary steps in the cases which are not mentioned in this regulation.

2. Penalties for Officials and Coaches

S. No.	CASE	PENALTIES
1	Unsporting conduct (Gesture by hand) Aggressive words	Suspension from supervising the team for 2 matches + \$ 2000 Fine
2	Tearing the Players Registration Form or any other official papers related to the Match	One year suspension + \$ 5000 Fine
3	Trying to make physical assault	3 match suspension + \$ 3000 Fine
4	Leaving the podium and Incitement towards it	1 - 3 match suspension + \$ 3000 Fine
5	Incitement which results in withdrawing	One year suspension + can rise the matter to the Executive Committee + \$ 5000 Fine
6	Physical Assault (spitting on the persons, Referees, Referees on the bench, Players, Officials, Representatives of AHF, will be considered as physical assault, so will be penalized according to the Article no. 8.10.a – which is suspension with report)	One year suspension + can rise the matter to the Executive Committee + \$ 5000 Fine
7	Causing A Riot by Raising the spectators	One year suspension + preventing him from entering the playing hall + can rise the matter to the Executive Committee + \$ 4000 Fine
8	Joining his team during the suspension period	Suspension until the end of current championship + \$ 3000 Fine
9	Producing fake documents	One year suspension + taking the responsibility of the consequences + \$ 5000 - \$ 8000 Fine
10	Making Remarks through Media by the coach or official or any responsible person which creates disrepute to the Game	One year suspension + can raise the matter to the Executive Committee + \$ 4000 Fine

-The Technical Committee has the right to take necessary steps in the cases which are not mentioned in this regulation.

3. Penalties for the Federations and the Clubs

S. No.	CASE	PENALTIES
1	Withdrawal from the AHF championships before the Draw	Warning + Deduction of the participation fee
2	Withdrawal after the Draw	1- Suspension from participating in the next championship of same category 2- \$ 20000 Fine paid to AHF 3- No Refund of the Participation fee 4- Paying a fine of 20% from the Accommodation fee to the Organizer.
3	Withdrawal during the championship	1- Suspension from participating in the next championship 2- \$ 30000 Fine 3- paying the full accommodation fee
4	Excuse from organizing the championship after agreeing on it and before signing the contract	\$ 30000 Fine
5	Excuse from organizing the championship after signing the contract	1-\$100000 Fine 2- Non attribution of any championship to them for the next one year
6	Non-compliance in executing the decisions of the Council and Executive Committee	1- suspension for one calendar year from all the activities from the date of the decision 2- \$ 20000 Fine 3- Raising the matter to the Executive Committee for necessary action
7	Manipulating the results In the light of the report submitted by: Referees or Match Supervisor or Technical Committee	1-Nullifying all the Results of the championship 2-Deprivation from completing the Matches in the championship 3- Raising the matter to the Executive Committee for necessary action
8	Withdrawing from World Championships or Olympic Games after qualifying in the continental qualification	1-\$ 100000 Fine 2-Preventing from participating in the forthcoming Qualification for the same championship
9	Breaching of advertising regulations	\$ 5000 Fine
10	Participating of a player registered with a club during the Asian Club League Championship and transferred to another club in the same season	1- A fine of \$ 30000 against the violating federation 2- A fine of \$ 20000 against the violating federation 3- Deprivation of the violating club from participating in first two championships continuously 4- Nullifying all the Results and its

		consequences of the violating club in the championship.

4. General Rules:

1. In case, the penalties are not paid in the stipulated period, the matter will be raised to the Executive Committee for necessary action.
2. The AHF Council and the Executive Committee have the exclusive right in the Interpretation of Articles and Items of this Regulation and take necessary steps in the cases which are not mentioned in this regulation.
